COMMUNITY PARTNERSHIPS GRANT - OUT OF ROUND APPLICATIONS

RECOMMENDATION:

That Council:

- 1. Supports the grant application received from Mission Australia for Homelessness Week 2024 to the value of \$3,100 (ex GST).
- 2. Does not support the grant application received from Tourism Palm Cove Inc for Food and Wine Frolic; and
- 3. Delegates authority to the Chief Executive Officer in accordance with the Local Government Act 2009 to finalise any and all matters relating to the above funding agreements.

EXECUTIVE SUMMARY:

Two applications requesting support through the Community Partnerships Grant stream have been received to a total value of \$23,015 (ex GST). These applications have been considered on an out of round basis due to the event dates falling outside of the current grant round.

Mission Australia has applied for support with the delivery of an event that forms part of Homelessness Week 2024. The purpose of the event is to highlight the changing face of homelessness in the Cairns region and will do so via a community event which will be held on the Cairns Esplanade on 7 August 2024. Officers recommend funding this application to the value of \$3,100 (ex GST).

Tourism Palm Cove Inc is auspicing an application on behalf of the Palm Cove Surf Club to deliver an event at the Palm Cove Surf Club, called Food and Wine Frolic on 3 August 2024. Whilst the Food and Wine Folic is an enjoyable event for Palm Cove and surrounding residents to enjoy, officers have determined that the event is primarily a commercial venture.

BACKGROUND:

The intent of the Community Partnerships Grant is to assist community groups and organisations with the delivery of events, activities and programs that enhance the lives

of local communities, celebrate important community occasions and provide opportunities to develop social cohesion and connection in the Cairns region.

The Community Partnerships Grant provides assistance through cash and the provision of Council venues and resources. The maximum amount per application is \$25,000 (ex GST).

Both applications were considered on an out-of-round basis due to the event dates falling outside of the current grant round.

COMMENT:

Mission Australia for the Homelessness Week 2024 to the value of \$3,100 (ex GST). Event date: 7 August 2024

With a commitment to end homelessness in Australia and a strong belief that every person across the country should have access to safe and secure housing, Mission Australia will host this event as part of National Homelessness Week 2024.

The purpose of the event is to highlight the changing face of homelessness in the region specifically that the impact of the recent floods along with low housing stock has created a situation in which homelessness now affects more of our community.

The event will feature a documentary film with stories of family's experiences with homelessness and to recognise and acknowledge that homelessness looks different for everyone. Other activities will include a Welcome to Country and Smoking Ceremony, cultural dances, guest speakers, interactive games, local entertainment and food.

It is anticipated that 200 people will attend the free and inclusive event to be held at Sea Eagle Lawn, Cairns Esplanade.

Since 2023, Council resolved to support Mission Australia to a total value of \$1,000 (ex GST) with a further request under consideration at this meeting. This is detailed in the table below.

Mission Australia is requesting \$3,015 (ex GST) towards the delivery of the event.

Officers are supportive of this request by providing up to \$3,100 (ex GST) consisting of \$2,600 cash (ex GST) and the provision of venue hire and associated resources up to the value of \$500 (ex GST).

Tourism Palm Cove Inc for the Food & Wine Frolic to the value of \$20,000 (ex GST). Event date: 3 August 2024

The Food and Wine Frolic is being delivered by the Surf Club Palm Cove Inc. under the auspice of Tourism Palm Cove Inc. The purpose of the event is to assist with reigniting Palm Cove as a place for locals to visit and enjoy once again.

The event was first held last year and was well subscribed with approximately 2,000 people attending. The event was free with an option for attendees to give a gold coin to the Cairns Surf Lifesaving Club. Unfortunately, the event produced a significant loss to the organisation and a decision was subsequently made to charge a \$15 - \$20 entry fee at this year's event to assist with mitigating this loss.

The 2024 event mirrors the previous successful year with the event being held in the carpark at the club and featuring the INXS Tribute Band for the second time. It is estimated that 1,500 people will again attend the Frolic, contributing at least an additional \$22,500 income towards the event. There is no mechanism for gold coin donations for the Cairns Surf Lifesaving Club this year.

Since 2019, Council resolved to support Tourism Palm Cove Inc to the value of \$90,500 (ex GST) for the following events.

Officers determined that the event is primarily a commercial venture and therefore do not recommend the application for funding.
