LOCAL LAW DECLARATION OF DOG OFF LEASH AREAS AND ANIMAL PROHIBITIONS

RECOMMENDATION:

That Council:

1. Resolves, pursuant to section 25 (1) of Cairns Regional Council Local Law No 2 (Animal Management) 2016 (“the Local Law”), to declare that animals are prohibited in the public places identified in attachment 1, effective from 1 July 2024; and
2. Resolves, pursuant to section 26 (1) of Cairns Regional Council Local Law No 2 (Animal Management) 2016 (“the Local Law”), to declare that the specific areas within the public places identified in attachment 2 are areas where a dog is not required to be on a leash (a dog off leash area), effective from 1 July 2024; and
3. Delegates power to the Chief Executive Officer pursuant to section 257 of the *Local Government Act 2009* (“the Act”), to:
 - a. Take all necessary steps in accordance with Section 25 (3) and 25 (4) of the Local Law to notify the public of the declared areas in accordance with Section 25 (1) of the Local Law.
 - b. Take all necessary steps in accordance with Section 26 (2) and 26 (3) of the Local Law to notify the public of the declared areas made in accordance with Section 26 (1) of the Local Law.
4. Notes that a further report will be made to Council after a thorough review of these areas including the public feedback received as part of the Local Law Amendment process conducted in 2023.

EXECUTIVE SUMMARY:

This report is provided to ensure that the off leash areas and the animal prohibitions areas currently within the Local Law are declared prior to the commencement date of 1 July 2024. Without a resolution declaring these areas Council will not have the ability to conduct any enforcement of animal prohibition areas and any current dog off leash areas

in the region on the commencement date for the amended Local Laws on 1 July 2024.

A review of these areas is currently underway, and a further report will be provided to Council upon completion of this process. The feedback provided as part of the public consultation period for the amended Local Laws will be considered in the review so as to inform any changes to the declared dog off leash or animal prohibitions areas.

BACKGROUND:

Council Officers undertook an extensive review of the following local laws through the Local Law Amendment Project in 2023:

- *Local Law No. 1 (Administration) 2016;*
- *Local Law No. 2 (Animal Management) 2016;*
- *Subordinate Local Law No. 2 (Animal Management) 2016;*
- *Local Law No. 3 (Community & Environment) 2016;*
- *Subordinate Local Law No. 3 (Community & Environment) 2016;*
- *Local Law No. 5 (Temporary Homes) 2016;*
- *Local Law No. 6 (Camping Grounds, Caravan Parks and Shared Facilities Accommodation) 2016;*
- *Local Law No. 7 (Human Remains and Cemeteries) 2016;*
- *Local Law No. 8 (Swimming Pools) 2016;*
- *Local Law No. 9 (Temporary Entertainment Events) 2016;*
- *Local Law No. 10 (Cane Railways) 2016;*
- *Local Law No. 11 (Local Government Controlled Areas and Roads) 2016;*
- *Subordinate Local Law No. 11 (Local Government Controlled Areas and Roads) 2016;*
- *Local Law No. 12 (Parking) 2016;*
- *Subordinate Local Law No. 12 (Parking) 2016;* and
- *Local Law No. 14 (Town Water) 2016.*

Council resolved on 8 November 2023 to endorse amendments to the Local Laws upon consideration of the public consultation received. The endorsed amendments to the Local Laws included the removal of the dog off leash areas and the areas where animals are prohibited from within the Local Laws. The Local Law was amended to allow for these areas to be designated by way of Council resolution with specific requirements to be following which includes:

- Properly identify and describe all of the areas that have been declared and keep a register of the declared areas which records the details of the declared areas;
- Ensure the register is kept up to date and available to the public for inspection at all times;
- For any amendments to be made to the register following a resolution of Council, ensure that the public is notified of those changes for example through public consultation and notification of the resolution; and
- Take all reasonable steps to provide notice to the public of the declared area through signage in the area for example.

Previously, changes to these areas required an amendment to be made to the Local Law through the relevant legislative process which can be complex and time consuming. This

change allows for a more efficient and simplified process to add, remove or amend these areas that the Local Law applied to. This enables Council to be more agile in these processes particularly for dog off leash areas which are very well utilised by the community and can now be more easily amended or added as new residential developments occur throughout the region.

COMMENT:

Attachment 1 provides the names, locations, boundaries, mapping, descriptions, and details of each dog off leash area and animal prohibition area which will be included in the designation registers to be available to the public to view on Councils website from 1 July 2024. It should also be noted that these areas are already sign posted and have previously been through public consultation when originally included in the Local Laws.

Officers will engage with Council as part of their review of these areas and the associated Dog Off Leash Policy in the near future.

CONSULTATION:

The Act requires Council to carry out public consultation and consult with the relevant government entities about the overall State interest before amending or making a new local law. This process allows the community and the relevant State Departments the opportunity to provide written submissions outlining their support, objection, or comments regarding any of the proposed local laws being amended or made. This process was completed as part of the Local Law Amendment Project in 2023.

Public consultation

During the Local Law Amendment Project, Council undertook public consultation for a period of four (4) weeks from Wednesday 16 August 2023 until close of business Wednesday 13 September 2023. Council considered additional submissions received until close of business Friday 15 September 2023.

Public consultation consisted of the following:

- A public consultation notice was published in the Cairns Post on 16th August 2023;
- A public consultation notice was published on Council's website for the duration of the consultation period;
- The proposed Amending Locals Law and the New Local Law were published on Council's website for the duration of the consultation period;
- Copies of the proposed Amending Local Laws and the New Local Law were available to be viewed or purchased from each of Council's libraries and Spence Street Customer Service area; and
- A media release and Facebook post outlining that the consultation period was open.

It should be noted that the areas included in this report have all been through public consultation previously, are currently sign posted and are currently within Councils Local Laws.

Consultation

Council received responses which included 102 comments relating to 18 different dog off leash areas and animal prohibition areas. From the 102 responses received regarding dog off leash areas and animal prohibition areas, 48 comments were received in relation to dogs being included in the animal prohibition area of the CBD which were predominantly in favour of removing and/or reducing the area where dogs were prohibited. Due to the responses received regarding this public place, Council officers recommended that the area where dogs are prohibited be amended to reflect the needs of the community. It was recommended that the area where dogs are prohibited be reduced to the area of the Lagoon including its surrounding pathways which extends along the waterfront to the marina area as shown on the below map in yellow shading.



The remaining responses received regarding other dog off leash areas and animal prohibition areas are to be analysed and these areas will be included in a future report which will make recommendations relating to altering, removing or additions of any new dog off leash areas and animal prohibition areas.

OPTIONS:

Option 1: (Recommended) –

That Council:

1. Resolves, pursuant to section 25 (1) of *Cairns Regional Council Local Law No 2 (Animal Management) 2016* (“the Local Law”), to declare that animals are prohibited in the public places identified in attachment 1, with a commencement date of 1 July 2024; and
2. Resolves, pursuant to section 26 (1) of *Cairns Regional Council Local Law No 2 (Animal Management) 2016* (“the Local Law”), to declare that the specific areas within the public places identified in attachment 2 are areas where a dog is not required to be on a leash (a dog off leash area), with a commencement date of 1 July 2024; and

3. Delegates power to the Chief Executive Officer pursuant to section 257 of the *Local Government Act 2009* (“the Act”), to:
 - a. Take all necessary steps in accordance with Section 25 (3) and 25 (4) of the Local Law to notify the public of the declarations made in accordance with Section 25 (1) of the Local Law.
 - b. Take all necessary steps in accordance with Section 26 (3) and 26 (4) of the Local Law to notify the public of the declarations made in accordance with Section 26 (1) of the Local Law.
4. Notes that a further report will be made to Council after a thorough review of these areas including the public feedback received as part of the Local Law Amendment process conducted in 2023.

Option 2:

That Council does not declare any areas in accordance with Section 25 (1) or Section 26 (1) of the Local Law, noting that such an action would result in Council being unable to enforce Local Laws in animal prohibition areas and dog off leash areas from 1 July 2024.

CONSIDERATIONS:

Risk Management:

Reputation – The local laws have been reviewed and developed with the needs of the community in mind. The community is currently aware of these areas and without a declaration the powers within the Local Laws for these areas will not be available for use from 1 July 2024.

Governance, accountability and ethical decision making – The local laws provide mechanisms for decision making on certain topics and provide some of Council’s enforcement abilities. These provisions have been reviewed for consistency, fairness and transparency whilst allowing for agility and efficient in decision making.

Council Finance and the Local Economy:

The proposed declarations will not adversely impact upon Council Finances or the Local Economy.

Community and Cultural Heritage:

Council’s Local Laws have been reviewed to ensure the best interests of the community, by:

- enhancing public safety;
- enhancing the use and enjoyment of local government controlled areas and parks through effective management and regulation of certain activities; and
- enhancing the amenity of the local government area.

Declaration of these areas ensures that the provisions available in the Local Law are

utilised to maintain the current status quo of the areas identified.

Natural Environment:

The impacts and risks of harm to the natural environment are minimal as these declarations are confirming the areas currently within the Local Laws.

Corporate and Operational Plans:

The declaration of these areas by resolution aligns with each of the following focus area of Council's Corporate Plan:

Focus 3: Design for Liveability

The declaration of animal prohibition areas enables Cairns to be a better place to live by regulating certain behaviours, by promoting safety, harmony and good rule within the community.

Focus 4: Community & Culture

The declaration of dog off leash areas provides the ability for dog owners to utilise Council controlled land to exercise and socialise their dogs lawfully which meets the needs of the community.

Focus 5: Focused Council

The new streamlined process for declaring dog off leash areas and animal prohibition areas allows Council to be more responsive to community needs and wants and to changes within the region. It also allows Council to be able to manage animals that are not appropriate in certain areas.

Statutory:

Part 3 Division 1 of the Local Law specifies the requirements for Animals in Public Places. Section 25 of the Local Law sets out the specific process for exclusion of animals. This report ensures Council is meeting those requirements.

Part 3 Division 1 of the Local Law specifies the requirements for Animals in Public Places. Section 26 of the Local Law sets out the specific process for Dog off leash areas. This report ensures Council is meeting those requirements.

Policy:

Council's Dog Off Leash Area Policy and guidelines sets out a framework for establishment, provision and improvement of dog off leash areas, fenced dog exercise areas, and prohibition and restriction of animals in public places to meet community needs and maintain public and animal safety.

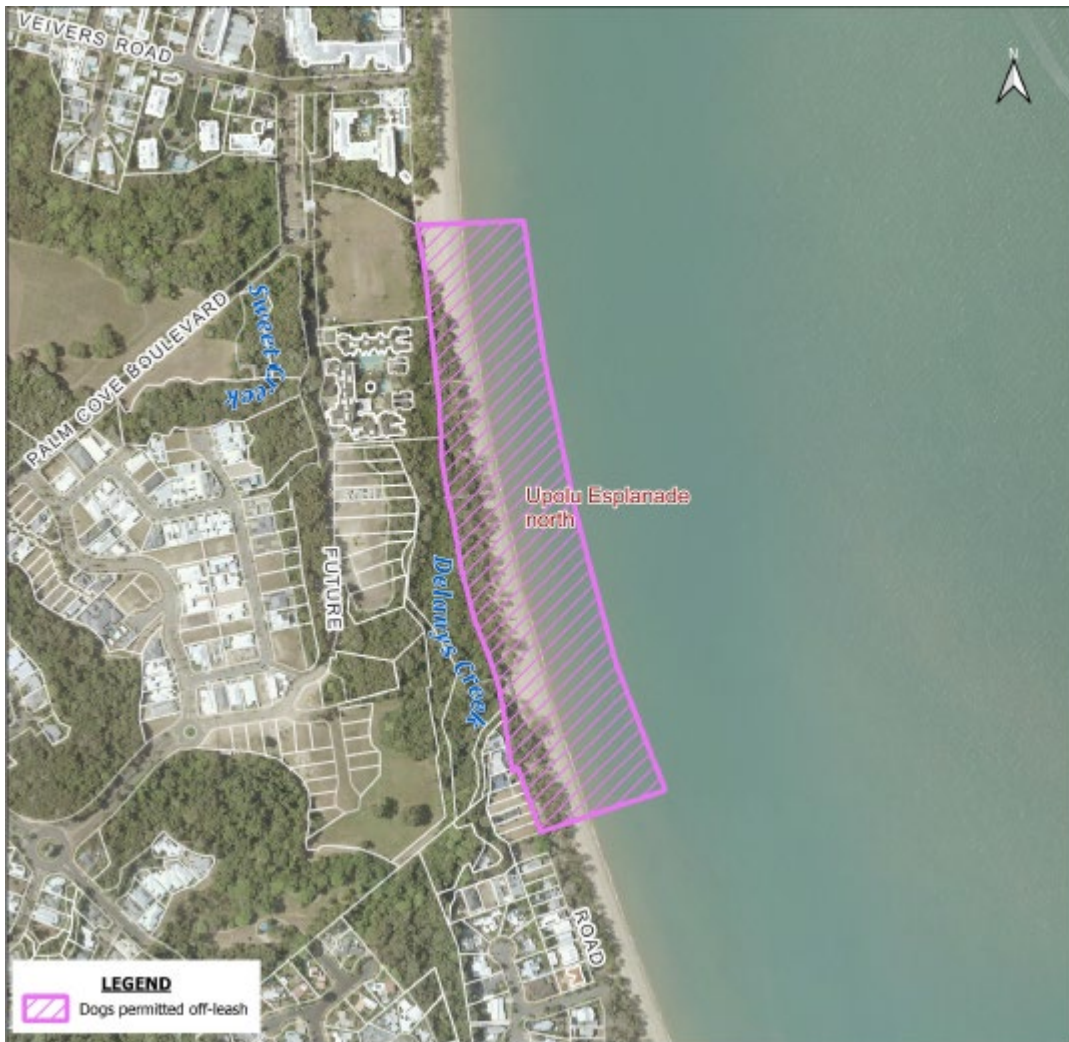

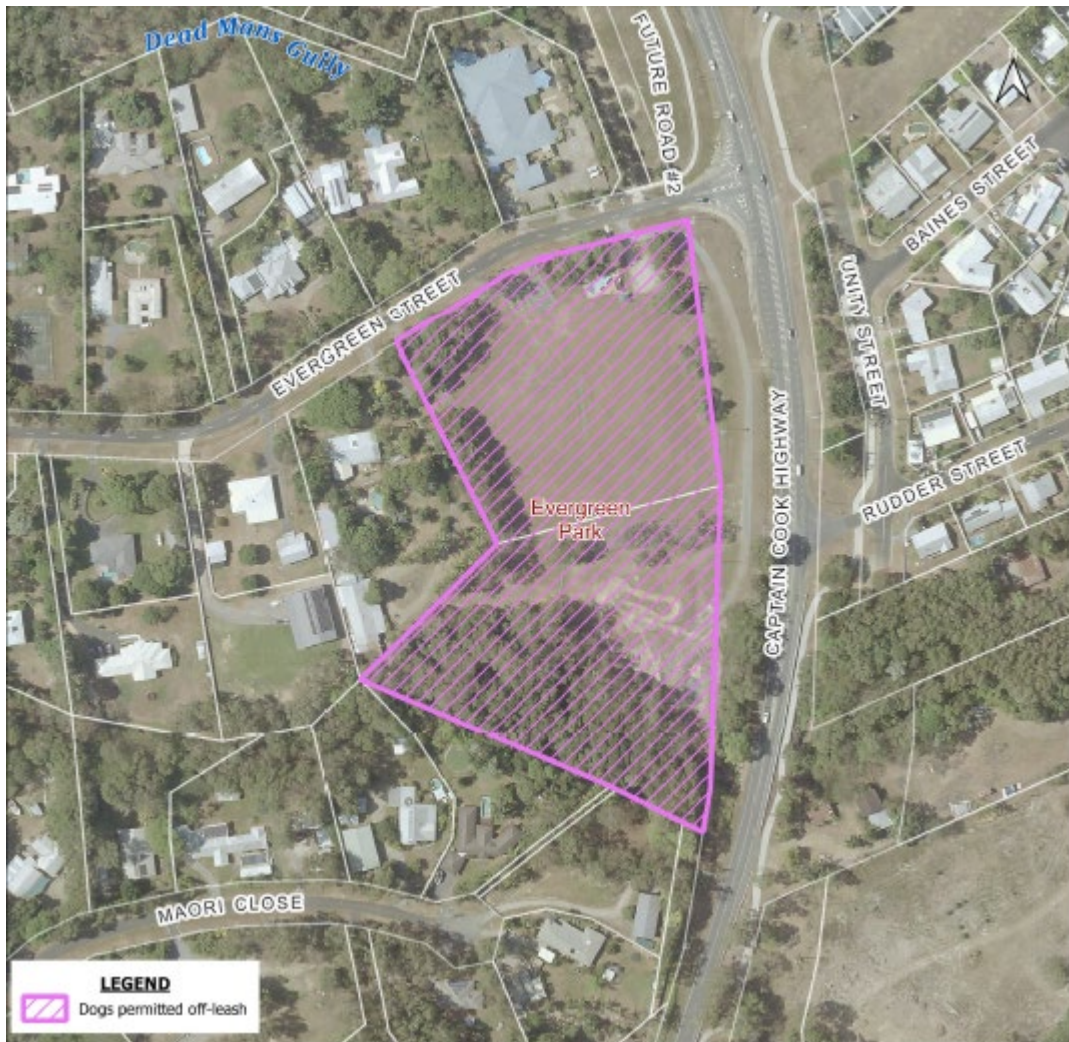

GORDONVALE: Part of Howard Bailey Park at the end of Klarwein Close being on the western side of the Klarwein Street entrance and behind houses in Highleigh Road and bounded by the drain at the rear.



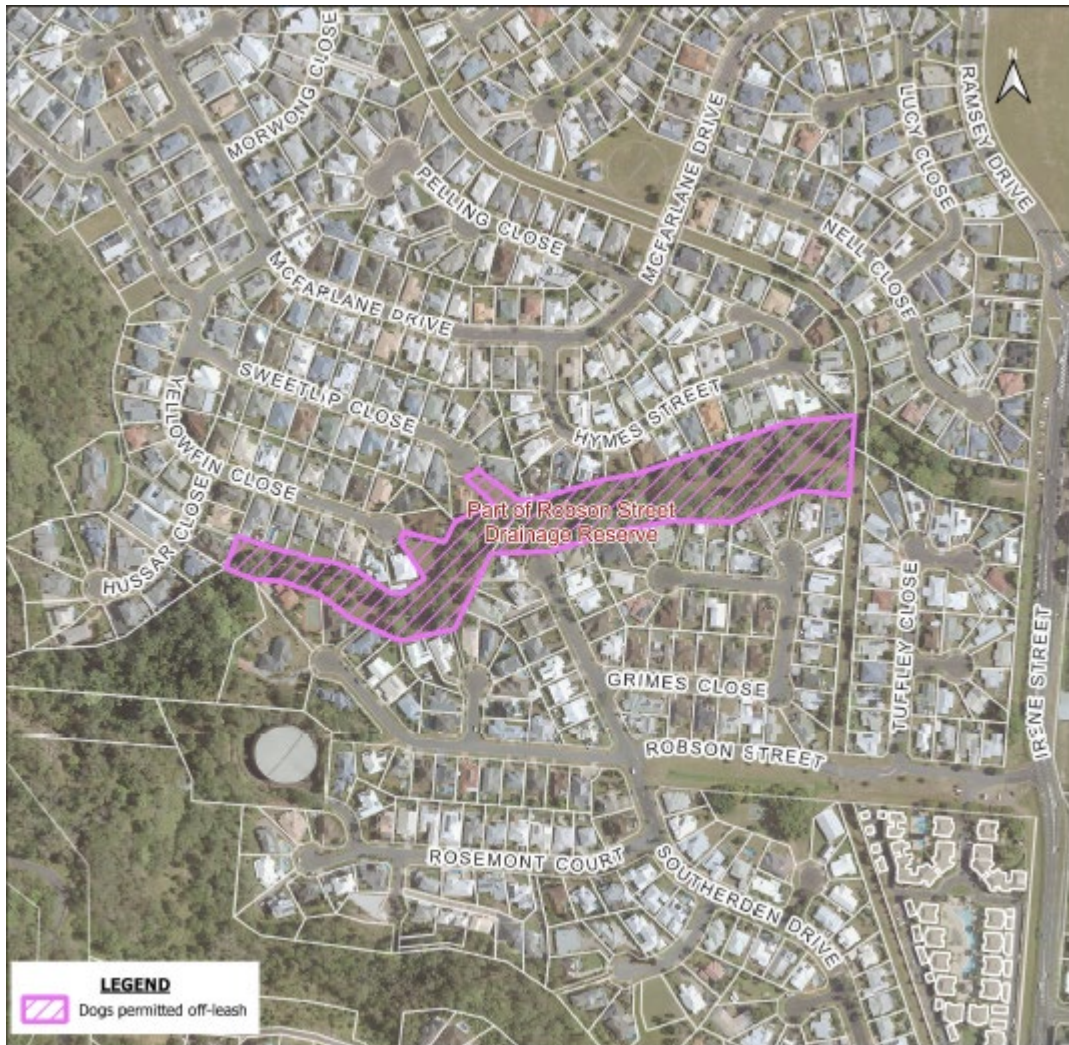
HOLLOWAYS BEACH: Beach at the northern end of Holloways Beach fronting Casuarina Street and north of Luke Street.



HOLLOWAYS BEACH: The southern end of Holloways Beach between Tamarind Street and Magnolia Street.

MOOROOBOOL: North of Langan Street, east of Irene Street, west of Carnation Drive and south of Marigold Close.



MT SHERIDAN: Sawpit Gully Detention Basin at Forest Gardens.



MT SHERIDAN: Trafalgar Detention Basin and Balmoral Close Park from the south of Trafalgar Road to the creek to the south and from Idalia Road to the property boundary to the west.

REDLYNCH: Part of Redlynch Village Green off Harvey Road, Redlynch being at the railway line end of the parkland and behind houses in Ficus Close.



SMITHFIELD: Part of the Rainy Mountain Park in Cumberland Avenue covering the northern end of the park behind houses in Survey Street and the fenced dog exercise area.



TRINITY BEACH: The beach from the northern end of Vasey Esplanade and north to the rocks.



TRINITY BEACH: The beach at the southern end of Trinity Beach to the South of Peacock Street.



TRINITY PARK: Half Moon Bay beach, Trinity Park to the south of the car park entrance.



WESTCOURT: Closed road reserve Mann Street between Lyons and Brown Streets.



WHITE ROCK: Part of Mercurio Street Park, White Rock, located on the western side of Mercurio Street and directly south of the storm water drain.



WHITFIELD: Engineers Park on the corner of Bott and McManus Streets, Whitfield.



WHITFIELD: Bunny Jarrett Park on the northern side of the drainage easement and creek at the corner of McManus and Bolton Streets, Whitfield and behind houses in McManus Street and Murchison Street.



WHITFIELD: Colin Penridge Park located to the north of Murchison Street and west of Hillview Crescent.
