EXECUTIVE SUMMARY:

The 2024-27 Works for Queensland (2024-27 W4Q) program is a Queensland Government program to provide funding to eligible councils to deliver infrastructure, planning, maintenance and capability development projects which support essential services, or contribute to community economic development or council sustainability. This initiative is delivered by the Department of Housing, Local Government, Planning and Public Works.

The intent of this report is to update Council on the background and status of the application for funding and agree the suite of projects to be lodged for funding.

BACKGROUND:

The 2024-27 W4Q program is a Queensland Government funding program to deliver infrastructure, planning, maintenance and capability development projects which support essential services, or contribute to community economic development or council sustainability.

The total budget for the 2024-27 W4Q program is \$300M. Each eligible local government will receive a base allocation of \$1.5M plus an additional amount calculated based on weighted population and unemployment figures in its local government area. Based on this methodology, an amount of \$18.17M has been made available to Cairns Regional Council, this represents a \$6M increase from the last round of W4Q from the Queensland Government.

The aim of 2024-27 W4Q is to support councils to deliver local infrastructure and maintenance, planning and capability development projects which:

- support essential services, contribute to community economic development and improve council sustainability.
- create and/or support jobs and deliver liveable communities where Queenslanders want to work, live and play.

Projects must be completed by 27 June 2027.

Councils are to prioritise projects that address local critical infrastructure and maintenance needs. An eligible project must be a project that is an essential services project or an economic development or council sustainability project. An essential services projects includes:

- critical infrastructure projects water and wastewater, roads and drainage, stormwater systems
- a disaster resilience and preparedness project
- a housing supply project
- a community safety and wellbeing project CCTV, active transport infrastructure, sport and recreation facilities

An economic development or council sustainability project includes:

- renewable energy transition project or local economic infrastructure Project Services
- a tourism infrastructure Project Services
- a community building and facilities project

Risk Management:

The proposed projects were selected to ensure Council would be able to meet the deadline requirements outline in the 2024-27 W4Q program guidelines while delivering critical infrastructure.

All projects nominated for funding under the 2024-27 W4Q program are ongoing annual renewal programs. Allocation of the funding to these projects will not have any adverse impact to the wider capital works program or delivery of the individual projects.
